

The congress has been designed to ensure maximum exchange with and between participants.



PARTICIPANTS BY FIELDS OF INTEREST

Satellite symposia

The ECNP Congress satellite programme is Europe's primary platform for presenting new industry science to the European CNS research and clinical communities.
